Lancaster County, SC, located in the fast-growing, highly desirable Charlotte, NC region, is the third fastest growing county of the 46 counties in South Carolina with a population of over 105,000. Lancaster County is home to one city and three towns. The county seat is in Lancaster with a population of nearly 10,000, and the other towns are Kershaw, Heath Springs, and Van Wyck.





The Lancaster County Public School District is highly regarded with more than 14,000 students and 4 high schools that stretch from one end of the County to the other. The University of South Carolina-Lancaster is based in the County along with an extension of York Technical College in the northern, unincorporated area of the County.

The area boasts an incredible quality of life for those individuals with varied interests. The mountains and the ocean are both within a three-hour drive; and within a short drive from Lancaster County, one can visit and experience a multitude of professional sports, world class cultural arts events and facilities, and access high quality educational and healthcare institutions. Lancaster County is also within an hour's drive from the Charlotte Douglas International Airport, which opens up international opportunities.







There are a number of advantages associated with living and working in Lancaster County. The Lancaster County Sheriff's Office has won numerous awards and is one of only nine South Carolina sheriff's departments accredited by the Commission on Accreditation for Law Enforcement Agencies Inc. (CALEA). Other Lancaster County Public Safety departments have innovative programs and have won numerous awards that help improve citizen safety. Lancaster County Emergency Medical Service (EMS) recently won the South Carolina Association of Counties 2020 J. Mitchell Graham Memorial Award for its EMS Boot Camp, an innovative program that recruits and trains new Emergency Medical Technicians (EMTs) through an on-the-job training program, which could help address a shortage of EMTs seen across the State. Lancaster County Fire Services has an innovative volunteer Recruitment and Retention program that includes training for future firefighters at a local high school.

Other community benefits to living and working in Lancaster County include shopping, restaurants, movie theatre, community playhouse and a small intimate performing arts center. Recent growth in Lancaster has been driven by a high quality of life and, in part, by lower property taxes than our neighbors in North Carolina and by a pro-business environment.

We are a smaller office employing only 20 attorneys along with 20 support staff personnel. The offices handle prosecution of cases ranging from magistrate level (lower court misdemeanor) cases, juvenile criminal cases as well as circuit court misdemeanors and felonies. While some of our prosecutors specialize in case types, such as criminal sexual conduct cases or domestic violence cases, others handle a wide range of cases both violent and non-violent. With terms of court nearly every week across the circuit, court time is prevalent and new assistant solicitors would be able to gain valuable experience right away. The Sixth Circuit boasts many diversion programs, including Drug Treatment Courts for adult and juvenile defendants and Veteran's Treatment Courts. The Mission of the Sixth Circuit Solicitor's Office is to uphold the Constitution and the laws of this state while seeking justice in a fair, ethical and timely manner thereby preserving the safety of our communities.
