The South Carolina Commission on Prosecution Coordination (SCCPC) is now accepting applications for the 2024 John R. Justice Student Loan Repayment Program until **7:00 P.M., Friday, May 3, 2024**. The John R. Justice Loan Repayment Program provides student loan repayment assistance for local, state, and federal public defenders and state solicitors who commit to extended service in those roles. ***Please share the attached John R. Justice Student Loan Repayment Program Application Packet with the prosecutors and public defenders in your offices.***

This year, there is a total of \$89,920.00 for awards to eligible prosecutors and public defenders. This amount will be divided equally between the two groups, prosecutors and public defenders, with each group receiving \$44,960.00. All eligible prosecutors and public defenders may apply (please see the Application Packet for eligibility guidelines).
